FY 2023 Supplemental Budget

Mayor Muriel Bowser's Fiscal Year 2024 Fair Shot Budget and Financial Plan, delivered to Council on March 22, 2023, also included changes to the current FY 2023 budget and non-lapsing fund balances in local, special purpose revenue, dedicated taxes, and capital funds. These changes, summarized in the tables below, include:

- \$240 million in savings across agencies in local funds, largely from vacancy savings;
- \$230 million in increases under local funds:
 - \$187 million to pay for settled collective bargaining agreements;
 - \$19 million for COVID operations;
 - \$14 million for contingency cash repayment;
 - \$5 million for the Home Purchase Assistance Program;
 - \$1.3 million for auto fuel increased costs;
 - \$1 million for FY23 Council reduction for District's animal shelter services; and
 - \$1 million for increased costs to the Safe Passage program for students.
- \$96 million shifted between capital projects to fund:
 - \$30 million for the DC Archives;
 - \$15 million for the H Street Bridge;
 - \$7 million for the renovation of the Blair Men's Shelter;
 - \$7 million for the Central Cell Block portion of the Daly Building Swing;
 - \$7 million for DDOT's Safety Infrastructure Around Schools and TSI 2.0 initiatives;
 - \$6 million for the Arboretum Bridge and Trail;
 - \$6 million for Mac Arthur Boulevard School;
 - \$6 million for the Southeast Tennis and Learning Center;
 - \$5 million for CFSA's Comprehensive Child Welfare Information System;
 - \$3 million for DDOT's traffic management center relocation;
 - \$2.6 million for facility upgrades at the Department of Behavioral Health;
 - \$1.2 million for boiler replacements at schools and other critical systems replacements; and
 - \$614,000 for the Department of Healthcare Finance's enterprise data system.

The following document goes into greater details for each change, by appropriation title and agency, and provides a narrative summary of those changes. The appendix includes charts that detail the non-lapsing fund adjustments.
